## Section 4. First aid measures

### 4.1 Description of necessary first aid measures

### 8.2 Exposure controls

#### Appropriate engineering controls

- Use only with adequate ventilation. If user operations generate dust, fumes, gas, vapor or mist, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.
